## Supreme Court to Rule on EPA's **Climate Authority**

On October 29, 2021, the U.S. Supreme Court agreed to hear an appeal of the D.C. Circuit's decision vacating the Affordable Clean Energy (ACE) rule, the Trump Administration's action to address CO2 emissions from existing fossil-fired power plants. This marks the latest development in a legal fight over what authority the Clean Air Act confers on the EPA to regulate greenhouse gas emissions from the power sector—a fight that has spanned over six years and three presidential administrations. Depending on the outcome, the Court could open the door to significant new regulations or tie the Administration's hands by restricting the scope of EPA's authority under the Clean Air Act. #### Chairman's Comments 2021

Thank you so much for the opportunity to serve as our Chairman over these past two years. It's certainly been an experience given the global pandemic. As I depart from this experience, I want to leave you with a note about my expertise, the electricity market.


My first day in the industry was August 29, 2005, when Hurricane Katrina hit the Gulf Coast. Since then, it's been one revolution after the other. Hurricanes, natural gas shortages, shale gas revolution, 100 straight days of 100-degree heat, polar vortexes, recessions, a global pandemic, and the worst winter storm in 150 years... Now, we are dealing with a whole new set of circumstances, particularly in the Texas market. The political fallout from the winter storm has the Texas Public Utility Commission looking to restructure our entire market. Instead of focusing on the "lowest cost" power (often highly subsidized, unreliable wind power), they are now shifting the focus to "most reliable" power. These historic changes, the most we've seen since electricity deregulation passed in Texas in 1999, will most certainly lead to higher costs than you've seen over the past several years.

Those of you looking at the short-term market will see very significant increases in electricity rates. However, the longer-term markets are still relatively attractive for the time being. My recommendation is to consider longer term pricing at this time. Even if you have a few years remaining on your current agreement, now is the time to consider an extension which may not even begin for two or three years.

You're essentially in a lifetime contract for electricity, yet most consumers only know what they will pay for the next few years. With all of the structural changes in our electricity market along with the global pressures on our natural gas market, this may very well be your last opportunity to lock-in at or near your current rates well into the future. At the very least, it's worth a look.
